The excess division should not be opened without permission of the department. The excess division should not be opened without developing the fundamental requirements.

3. School should provide necessary Fundamental facilities like school site, Area, Building, Furniture, Faculties, and other economic facilities.
4. As per the Government order No. ED:14:S.E.S 98 dated 17-08-1998, it has been verified the matter of registered of primary of **Crescent International School** (Education Zone, Udupi) in Udupi Region.

According to the demand of locality and Villagers in the matter of providing fundamental requirements, it must be urgently fulfilled by School.
